<u>Summary</u>

The Illinois Council on Women and Girls met for its second quarterly meeting of 2024 in both the Chicago and Springfield office. The Council did not establish a quorum during this meeting, but the Lieutenant Governor's Office is exploring options to ensure quorum is established in the future. Additionally, Lieutenant Governor Stratton welcomed The Lieutenant Governor's Office's new Policy Director Nikki Giancola-Shanks to the Council, as well as recognized Edwidge Labbe's contributions to the Council as her time in the James H. Dunn Fellowship comes to a close.

The Lieutenant Governor then announced the passing of the 16th balanced budget. This budget shows the administrations' continuing values, including transformative investments in early childhood, K-12 and higher education, health and social service programs, workforce development, restorative justice and violence prevention efforts, and investments in our cultural and natural resources, as well as positive initiatives for women and girls. Lieutenant Governor Stratton then recognized the passing of the Birth Equity Initiative, known as HB5142, in both the House and the Senate, which will create equity throughout pregnancy, postpartum care, and newborn care and allow women to make choices over their birthing options. The Lieutenant Governor reported on the We Thrive initiative, which is working to help women of all ages and backgrounds feel more confident when handling their finances. Lieutenant Governor Stratton moved on to addressing the importance of reappointments and the work of filling vacancies on the Council. The Office of the Lieutenant Governor is working to ensure that these vacancies are filled.

Each subcommittee on the council then gave updates on their work. The Lieutenant Governor first recognized the vacancy for chairperson of the Health and Healthcare committee, as Dr. Vidhya Prakash has stepped down from the Council. The Council then heard updates from the subcommittees of Leadership and Inclusion, Gender-Based Violence, and the Girls Committee, as well as any member updates. Lieutenant Governor Stratton adjourned the meeting while reminding members of the quarterly three meeting taking place on Wednesday, September 25th, 2024, at 4 pm. No votes were taken during this meeting.
