Illinois Council on Women and Girls 4th Quarterly Meeting Minutes Wednesday, December 11, 2024

Summary

The Illinois Council on Women and Girls met for its fourth quarterly meeting of 2024 in both the Chicago and Springfield office, as well as virtually. Lieutenant Governor Stratton directed Maria Peterson to conduct a roll call to establish quorum. As quorum was established, the Lieutenant Governor entertained a motion to approve the public agenda, which was moved by Ines Kutlesa, seconded by Wendy Pollack, and approved. Lieutenant Governor Stratton then entertained a motion to approve the meeting minutes from the Q3 meeting on September 25th, 2024, which was moved by Kaethe Morris Hoffer, seconded by Sylvia Collins, and approved. Lieutenant Governor Stratton then welcomed new member Ashley Thoele of the Department of Public Health to the Council.

The Lt. Governor announced the new cohort of the 2nd annual Girls Lead program, which includes girls from 30 counties across Illinois who will spend time shadowing a woman in leadership in state government. Lieutenant Governor Stratton also announced the new cohort of the 2025 Girls Committee, which serves as a subcommittee of the Council consisting of high school girls across Illinois who will inform the Council on the pressing issues that girls face in Illinois. The Lieutenant Governor then announced the release of the 2024 Illinois Council of Women and Girls report, which highlights the work of the Council over the year.

The Council was joined by Michelle White and Rebecca Estrada of the Illinois Department of Commerce and Economic Opportunity (DCEO). Michelle and Rebecca presented on the business resources and opportunities that DCEO offers to women in Illinois through their toolkit. The Council then heard updates from the subcommittees of Leadership and Inclusion, Gender-Based Violence, Academic and Economic Opportunity, and the Girls Committee, as well as any member updates. Lieutenant Governor Stratton entertained a motion to adjourn the meeting while reminding members of the first quarterly meeting of 2025 taking place on Tuesday, March 11, 2025, at 4 pm, which was moved by Jackie Matthews, seconded by Jane Flanagan, and approved.
