 - 1. Feeling perplexed, but focused on getting the good work done
 - ii. Veronica Espina
 - 1. Feeling devastated but hopeful
 - 2. "I live in a community where there is anti-black, anti-immigrant, and anti-protest sentiments. Right now, I feel devastated, but hopeful we can create a critical mass to make changes."

iii. Ines Kutlesa

1. "We fight for equality in all of life's domains and to see this disregard for George Floyd's life is the height of systemic racism. The focus of this Council is to reduce violence, discrimination, and disenfranchisement. Perhaps we can talk about forming a task force so that the Council can be a part of the conversation around Illinois on these issues."

iv. Theresa Forthofer

- 1. "One of my early frustrations was around the grouping of people looting, people protesting, and people being violent all into one group."
- 2. "I sent out a message to my staff the other day and I received a lot of support."

v. Aileen Kim

1. "Everything has me questioning what's next and what we can do differently. It's all too frequently in the news that we hear about violence against Black bodies, so I've been thinking about what we can do differently. We need to operate using a racial, social, and economic justice lens in our work to capture all the issues that people in our state are facing."

vi. Kaethe Morris Hoffer

1. "What we need is to lean into the people who have expertise in dealing with white supremacy. The rage of people who live under the boot of white supremacy needs to be uplifted. The work this Council can play in this is similar to the work that our Gender-Based Violence Committee has done — we can amplify, promote, and support the leadership and wisdom of folks that have so much wisdom in guiding us to ending white supremacy."

vii. Maaria Mozaffar

 "We cannot waste time. White supremacy has entered all spaces of our policies and it behooves us to understand that nexus. I look forward to being clear in the work of the Council that there is no place for white supremacy."

viii. Wendy Pollack

1. "I am distressed and it shows how much I have to do individually as a white person, as do all white people. There is a lot of work to be done."

ix. Brandy Donaldson

1. "Two young, Black people have been murdered during demonstrations in the Quad Cities area, and we're dealing with that. No one is being held responsible for these deaths. We had peaceful protests on Saturday during

the day and at night it turned terrible. There's now a curfew on both sides of the river in the Quad Cities area. "

2. "Two minutes before this meeting, I and others in the Quad Cities area had a meeting with elected officials and others. I'm a Black, gay women — I personally understand that communities have been fighting for justice and equity for the longest. I'm now looking to my elected for change. I've been to a ton of protests and demonstrations, so I am focusing more of energy of holding my elected officials' hands to the fire — whenever my elected officials see me, I am going to ask about racial justice."

x. Vidhya Prakash

- 1. "My feelings ranged from rage to disgust to despair, but I'm an optimist, and our state leadership has given me hope. A protest I recently attended also gave me hope."
- 2. "Obama emphasized that in terms of solutions it begins with modeling, being specific, and relying on our local and state governments. I think this Council ought to keep this in mind as we move forward with solutions."

xi. Monique Garcia

1. "I am in awe of the amazing and powerful insight that everyone has offered so far. I am sad, angry, and tired. This is not the first time that the unjust treatment of Black bodies has occurred — or the second time. This is rooted in the founding of our country and it is way past time for us to move on. There needs to be more than statements, tweets, and black boxes, so I am looking for incremental changes and holing people accountable."

xii. Amina Jaffer

- 1. "I am very grateful for the leadership at the state level. A week ago, a lot of people didn't realize that racism what a part of our communities. It is unbelievable that people are so blatantly racist and that they get away with it. The dust must come out from the rug, so I am happy about the protests that occurred.
- 2. "If we get past the scary tensions of the moment, I think we have another wave of elected officials coming just as took place with the recent historical election of women elected officials."

xiii. Sylvia Perez Collins

1. "I echo what has been said about feeling proud of the protests — across the world. I marvel that there are people from other countries that realize our country can be better than she is."

xiv. Ibie Hart

1. "I took today off because as someone who does a lot of anti-racist work and works for minority businesses in DCEO, it's been difficult. But, I think we can get to the root and push for things we couldn't before."

xv. Selma D'Souza

1. "I appreciate everyone's comments and the Lt. Governor giving us the opportunity to speak. I came to this country as a child when I was 7 years old. This country and state have made a progress since then, but it feels like we're taking steps back sometimes."

xvi. Donna Hardy

1. "Today my agency has been thinking about how to give staff a voice. We've set up 12 sessions with 10-15 people each and allowing them to talk about what's going on. A lot of people are hurting and feeling

frustrated. Creating that safe space in your workspace is crucial. You spend a lot of time with you coworkers in the office and one of the ways to build bridges is to spend time with people away from work."

2. "I have a son who's 23 years old. I recently asked him what's the end goal, and he said 'at the end of the day, we're in the midst of a pandemic and youth unemployment is the highest it's been and we're mad. Think about the crushing debt we're under and think about all the minorities who've been hurt by COVID-19 who are the essential workers because these are the people they tell to go to work to ensure the system runs and they won't even give them benefits.' It made me realize that bringing in young people like this is important to the work we're doing."

xvii. Marina Faz-Huppert

1. "I've been inspired by what everyone's saying. Thank you for allowing us to utilize this platform to raise voices and move us forward."

xviii. Jaclyn Matthews

1. "It's been amazing and incredible to hear what folks are saying today. I was texting with my mom and she was telling me about some of her own experiences. She was talking about how my grandad could not get a business loan, as a Mexican man, until someone pointed him in the direction of a loan officer that could help and how that changed the direction of the next couple of generations. As I think about that and my work at the Illinois State Board of Education, I think about how more than half of our students in Illinois are BIPOC and 80% of our teachers are white. I'm excited about the role of this Council in think through some of these systemic challenges and empowering the voices of girls in these conversations."

xix. Kelly Fair

1. "I sometimes feel that in the space of public service people ask 'what is the next move,' and my next move is to breathe because to always be moving can be dangerous. I also need to breath for my team because they are dealing with kids who are struggling with not only COVID-19, but now also looting and other community destruction. What's exciting for me is that, while some young professionals don't always see the need for social justice, folks in my organization that did not get it before have found that it connected this week with their work and their lives."
